5.2. Special hazards arising from the substance or mixture

Exposure hazards: Flammable. Vapour may travel considerable distance to source of ignition and flash back. Forms explosive air-vapour mixture. In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Nitrogen oxides (NOx). Hydrogen cyanide (HCN).

5.3. Advice for fire-fighters

Advice for fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.
